 - 4.1 Building Code Ordinance Revisions including:
 - Amend Title 4, Chapter 2, Section 4-2-1, of the Nampa City Code to adopt the provisions of the “2021 International Building Code” relating to mass timber construction as required by 2021 IDAPA revisions.
 - Amend The 2018 International Residential Code to add Appendix Q – Tiny Houses and Appendix S – Strawbale Construction to add a new building type and an alternate construction type to the adopted building code.
 - Amend Title 4, Chapter 2, Section 4-2-2 as follows: Amend IBC/IRC section 105.2, "Work Exempt From Permit; Sub-Section: "Building" to modify exempt items for clarification.
 - Amend IBC section 112/IRC section R111: "Connection To Service Utilities" to correct errors in ordinance language.
 - Adopt IBC 602.1.2 “Alternative Provisions” as required by 2021 IDAPA Revisions.
 - Amend IRC section R202, definition for "Townhouse" to coordinate with Planning and Zoning ordinance changes.
 - Amend IECC Section R403.3.1 as required by 2021 IDAPA Revisions.
 - Amend Title 4, Chapter 6, Section 4-6-1 through 4-6-5 - “Moved Buildings” to coordinate with Planning and Zoning ordinance changes.
